Asia's first Winter Youth Olympic Games in the Republic of Korea

Games name Winter Youth Olympic Games Gangwon 2024

Games dates (Fri) 19 January 2024 – (Thu) 1 February 2024, 14 days

Venues Pyeongchang County, Gangneung City, Jeongseon County, Hoengseong County

Participation scale 15,000 people (1,803 athletes) from around 79 countries

Sports programme 7 sports, 15 disciplines, up to 81 events

Vision

Youth celebrating peaceful coexistence and unity through sport to create a better future together

Comprised of 15 human rights experts from various fields (youth, women's rights, etc.)

– Role: Protect the safety of participants and monitor the overall operation of the competition

Human Rights Committee

Human Rights Charter

Includes 9 practices to realize human rights protection during the Games

| What situations constitute examples of human rights violations?

Physical violence

Inflicting physical pain (bodily harm, assault), confinement, enticement, etc.

Verbal abuse

Using insulting language or words that may cause harm to the body

Coercion

Disregarding a person's will or obstructing the exercise of one's rights

(Digital) sexual violence

Forcing a person to engage in sexual activity or non-penetrative sexual activity, making physical contact to make a person feel sexually humiliated, or making a person feel offended by using sexual language or action

Gangwon 2024 Human Rights Charter

I . Everyone is equal and no discrimination shall be tolerated

II. Children's rights shall be protected

- No form of verbal or physical harassment or abuse shall be tolerated.

III. Rights to physical and mental health shall be upheld

- Children and youth are entitled to safeguards so that they can participate in the Games safely.

IV. Quality labor shall be protected

- All workforce and volunteers shall have fair working conditions.

V. Freedom of expression shall be respected

- Everyone's opinion is valued and any inappropriate situation shall be reported to the Gangwon 2024 Organising Committee.
- VI. Human rights risks shall be predicted and preemptively prevented
- VII. Shared commitment shall be made regarding human rights
- VIII. Active participation shall be ensured to solve problems effectively
- IX. Monitoring and approach to relief measures shall be practised
- ** Commitment of the Gangwon 2024 Organising Committee to ensure the safety and well-being of all participants

Affected party

• Those who experience a human rights violation related to the Games (spectators, volunteers, participants of cultural programmes, etc.)

Complainant(Reporter)

• Victims or third parties who are aware of the violation

What we will do

- Report human rights violation (complainant) ▶ Receive report (Organising Committee)
- ▶ Conduct victim counselling and provide necessary support. Identify actions to take, including referrals to relevant organisations that can provide support.
- * Referral to law enforcement for criminal cases
- The confidentiality of the complainant's identity, the details of the incident, and any other information obtained during the investigation will be maintained.
- No adverse action will be taken to the complainant.
- $\bullet \ \ Spatial \ separation \ (e.g.\ emergency\ shelter)\ will\ be\ provided, if\ desired\ by\ the\ complainant.$
- Secondary victimisation will be prevented and referrals to appropriate support organisations (e.g. psychotherapy, medical facilities) will be made.
- The victim will be immediately separated and a report to law enforcement will be made depending on the severity of the incident (transfer of case).
